## Documents Checklist for Chile:

#### Please note that currently Chilean government issues E-visa for Bangladeshi.

#### Diplomatic Passport Holders:

Requesting a diplomatic or official visa, after the pandemic, the Chilean Ministry of Foreign Affairs issues courtesy visas to diplomats and persons with official passports who travel to Chile on behalf of their government.

To apply for such a visa, a note verbal is required to be sent to the Embassy of Chile in India, informing: name and passport number of the officials traveling, the purpose of the trip, and the dates applicants will stay in Chile.

Chilean consulates will only process Temporary Admission Visas (Previous Tourist Visa). This types of visa allows citizens to visit Chile for up to 90 days for recreational, sports, health, study, business, family or other similar purpose.

After getting all documents the Honorary Consulate of Chile in Bangladesh will conduct a prescreening for ensuring the eligibility of applicant. If the applicant finds eligibility, the consulate give him/her the instruction for the next procedure.

Tourist Visa allows short term stays to enjoy tourist attractions

- Tourism
- Sports
- Medical Treatment
- Business
- Family or social visits
- Religious Purpose

Following Documents must be submitted:

- 1. Original valid passport ( with validity at least for 6 months)
- 2. Complete visa application form dully typed in Block letters (Hand Written is not allowed and information should matched with passport)
- 3. One recent white background passport size photograph.
- 4. Flight and tours itinerates ( with confirmed travelling dates)
- 5. Proof of financial security ( if business purpose company bank statements for next six months/ persons visa personal account statements of the last 6 months)
- 6. A letter explaining the reasons you are travelling
- 7. Letter of invitation (if applicable)

### **Student Visa:**

Regarding Student Visa an academic course in Chile that lasts more than 90 days then applicant need a student visa.

For these student need to submit letter of enrollment/ confirmation from the Chile educational institution, police clearance certificate, a health certificate stating that student won't carry a contagious disease, Proof of sufficient financial means to provide for applicants stay in Chile, Proof or legal status,

After a successful filling the application form, applicant will get an email whether he/she is denied or approved.

It is suggestion that, kindly start the procedure at least 2 months before travelling.

Also, advice do not buy airline ticket before having visa.

There is no possibility to give any information by phone, since this is a data information procedure based in Chile.

Minors Under 18

- Birth Certificate
- A notarized written authorization to travel from the parent/s or legal guardian/s if the child is traveling alone or with someone other than the parents.

#### Visa Payment

You will be issued a payment slip for the amount to be deposited in the consular bank account in Delhi. The fees can also deposit by online.

Please note we are (Consulate of Chile in Bangladesh) unable to receive any kind of payment, money or cheque.

#### **Charges for Bangladeshi Citizens:**

Single Entry: \$10 up to 90 days stay

Multiple Entry: \$18 up to 90 days

TEMPORARY Visa: \$12

SUBJECT TO CONTRACT Visa: \$12

STUDENT Visa: \$12

Visas to Bangladesh:

1. Chilean national can obtain Bangladesh visa on arrival at the port of entry for a fee of USD 54 (approx.) for 30 days as a tourist. You may also need two passport size photos with you, in case.

2. Please be reminded if your profession is JOURNALIST, REPORTERS, STUDENT OF JOURNALISM FACULTY, EDITOR OF A NEWS AGENCY/NEWSPAPER you may not be granted visa at the port of entry. So make sure your profession is none of the above in order to avoid any uncomfortable situations at the port of entry.

3. Chilean citizens with Diplomatic/ Official passports with a minimum of 6 months of validity do not require entry visas to Bangladesh for a maximum stay of 90 days in the Country.

#### **General information:**

Dhaka is the capital of Bangladesh. Hence the Honorary Consulate of Chile in Bangladesh is located in Dhaka. But, the Embassy of Chile is stationed in New Delhi, India from where the visas are issued for Bangladeshi applicants.

The Consulate of Chile in Dhaka attends from Sunday to Thursday, from 10:00 a.m. to 1:00 p.m.
